



LEGISLATIVE INFORMATION

The Hawaii Legislature has been busy this year, most of it in a negative way. These are just some of the proposed legislation that the HMDA has taken action on:

HB2890 would establish a **120db noise limit on motorcycles** – and just motorcycles- in any built up area. We opposed this one vigorously. If noise is a problem, then ALL noise should be considered in the bill, not just motorcycles, which represent a very small portion of the problem. The bill is currently in limbo. It has been referred to three different committees, but none of them have scheduled any action on it.

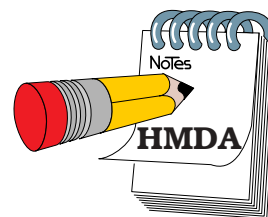
HB2954 was a sneaky one. On the surface, it was **a bill against street racing**. However, the very last paragraph included a provision that would have required **anyone transferring ownership of a motor vehicle to have a valid Hawaii driver's license**. The military represents a large chunk of our business, and many of them elect to maintain a driver's license in their home state. Committee members voted to hold this bill.

SB2513 would have charged an "advance abandoned vehicle disposal fee." \$250 would have been added onto every vehicle sold in Hawaii to pay for the cleanup of abandoned vehicles. **We teamed up with the automobile dealers association to defeat this one.** The bill would have generated an estimated \$23 million a year to handle a problem that the State says will cost less than \$4 million to handle. DUH!

SB2023 and SB2019 Two versions of the same thing. The bills would require a parent (or adult) over 21 to accompany any driver under 18 who is operating a motor vehicle between 10 pm and 4 am. Obviously, this is not practical on a motorcycle. **We're still fighting this one.**

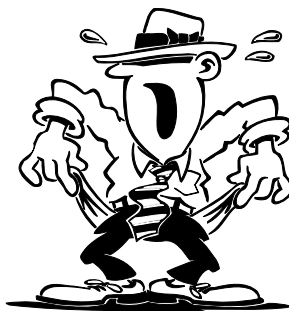

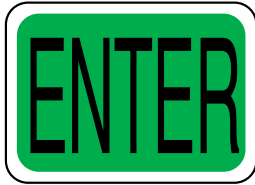

Many thanks to Rod for his efforts on behalf of the sport.

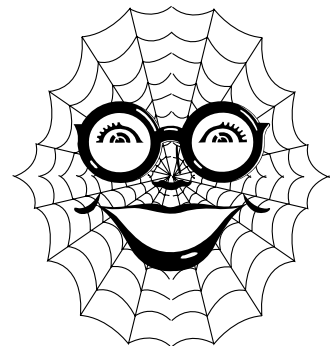
